General guidelines concerning the use of the Belgian NtM are described in the annual edition no. 1 of the Belgian Notices to Mariners.

Positions are given in the reference system World Geodetic System 84 (WGS84). Incorrect interpretation of the reference system can lead to errors in the position of several hundred of metres.

Depths (in metres): are reduced to Lowest Astronomical Tide (LAT) for tidal areas and to local dock datum for non-tidal areas.

Heights (in metres): drying heights are above LAT. Vertical clearance is above Mean High Water Spring (MHWS). Other heights are above Mean Sea Level (MSL). Heights for non-tidal areas are above local dock datum.

Directions, bearings, leading lines and light sectors (in degrees) are true reckoned from seawards.

2021-05/112 WINDFARMS - SAFETY ZONE - CORRECTION NTM NO. 01/2021

NtM 2021-01/057 replaced by:

OFFSHORE INSTALLATIONS: WINDFARMS

Under Royal Decree (KB) of 4 February 2020, publication 27 February 2020, a safety zone is established around wind turbines, wind farms and wind turbines zones.

The access to such a safety zone is forbidden, except in specific cases such as mentioned in the Royal Decree. Moreover, it is recommended to navigate well outside the limits of these zones.

This prohibition does not apply:

- 1. for warships, ships in use as marine assistance vessels, other vessel or aircrafts owned, managed or commissioned by a State, Region of Community and which at that time are exclusively used for non commercial government services;
- 2. For the means of the concessionaires and of the licence holders of the cable laying permits inside their own wind farm zone or the means deployed on behalf of the concessionaire or of the licence holders;
- 3. for the means of scientific research subject to prior consultation with the domain concessionaire and undiminished the relevant permit requirements;
- 4. for the means deployed for the maintenance of cables and pipelines;
- 5. for the means deployed based on articles 14 and 19, §2 of the Royal Decree (KB) MRP;
- 6. for the means deployed by the holder of the user licence based on article 23 of the Royal Decree (KB) MRP inside their own zone.

Nor does the prohibition apply:

- 1. for vessels in distress;
- 2. for saving human lifes and properties or attempts;
- 3. in cases of force majeure.

The safety zone of the windfarm 1 Oostelijke zone (which includes the windfarms Belwind-Nobelwind, C-Power A, C-Power B, Northwind, Rentel, Norther, Northwester 2, Mermaid, Seastar) is bounded by the following coordinates:
